- The Board of Trustees of the (Mississippi) Institutions of Higher Learning authorized Graduate Studies at JSU in 1953.
- The purpose was to carry out the graduation education mission of the college/university.
- The Graduate School was approved by IHL in 1972.
- Jackson State became a university in 1974.
- Doctoral Research Intensive classification was granted in 2000 by Carnegie Commission.
- Doctoral Research High Research Activity Classification was granted in 2006.

Vision of the Graduate School

 The Graduate School will be nationally recognized for following best practices in graduation education and quality leadership for graduate faculty, staff and students in support of educating our next generation of academic scholars.

Mission of the Graduate School
