**Name of Unit:** College of Public Service

**Mission:** The mission of the College of Public Service is to educate students from diverse backgrounds for outstanding professional service and to develop local, national, and international innovative leaders in the professional academic disciplines represented in the School of Social Work, as well as, Departments in Public Policy and Administration and Urban and Regional Planning.

**Introductions:** In 2003, the College of Public Service (CPS) became the fifth and newest college at Jackson State University (JSU), with an enrollment of approximately eight hundred students, established through a realignment of academic programs joined together through a common mission focused on service. Several programs in the college were founded or supported as a result of the Ayers Settlement of 1975, finalized some twenty years later around 1997. Since inception, CPS enrollment has grown over one hundred percent to 1689 students today. Over the past three years enrollment in the CPS has grown by 34%, and over the past academic year (2015-2016) by 18.7%, the largest enrollment increase among all JSU colleges.

In building our success as we move forward, the CPS has developed a five-year road map designed to increase both faculty and student access and success in all of our academic programs.

1. Achieve CSWE and NASPAA reaccreditation
2. Increase the number of departmental grant awards
3. Stabilizing vacant faculty positions and departmental leadership
4. Transition PPAD from a department to a school
5. Increase interdisciplinary collaboration with all JSU schools and colleges
6. Implement more online and dual degree programs
7. Improve student retention and graduation rates and increase student enrollment by 40% by 2020
8. Increase public and civic engagement services to state and local agencies

## **III. LOW PRODUCING UNITS**

The Urban Studies program was implemented at Jackson State University as an interdisciplinary program, which incorporates the tools of sociology, economics, and other social sciences to study city life, government, and services. Nationally, urban studies programs experiencing similar results have rebranded and marketed them as programs in “City Planning” with remarkable results. The Urban Studies program is also an important feeder program for our accredited Masters degree program in Urban and Regional Planning.

Our desire is to continue this program and implement innovative strategies to address “low productivity” such as: a) rebranding and marketing the program as “City Planning” and promoting to undecided majors, b) reducing the credit hour requirement from 124 to 120 hours, c) supplementing the curriculum with coursework in statistics, business, and social science research, d) promoting strong analytical, computational, communication, and research skills, e) providing a minor concentration in political science or public administration, f) providing internships and leadership opportunities, g) developing specialty areas (aging, family, criminal justice, healthcare), and h) promoting pathways for graduate degree qualification and program acceptance (MA Urban and Regional Planning).

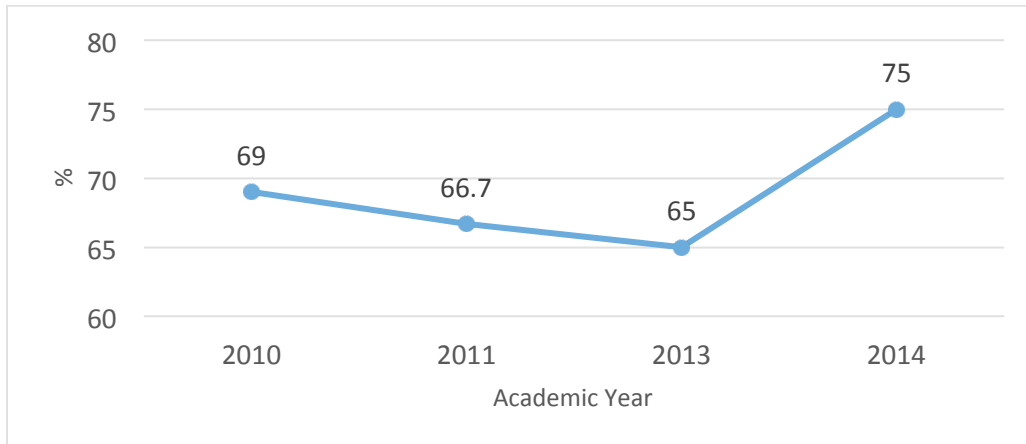

## **X. SUMMARY**

While the College of Public Service had an exceptional year in research, teaching and service our goal moving forward is to build on the successes experienced. The programs across the college have shared goals that can benefit from leveraging expertise to achieve them across divisional boundaries. For example, all programs would like to: 1) have stable leadership and adequate faculty, 2) enhance grantsmanship, 3) increase their enrollment, retention, graduation and job placement numbers, and 4) foster interdisciplinary collaboration and initiate dual degree programs. Three programs will be coming up for reaffirmation within the next two years, which includes the BSW and MSW programs and the program in Public Policy and Administration. Finally, the department of Public Policy and Administration is poised to become a fully independent school and has developed a long-term plan for achieving that goal.

The Bachelor of Social Work Program strives to prepare students for entry-level professional careers as generalist practitioners, graduate education, and leadership in social work and social services. The B.S.W. overarching goal is to help students develop a professional identity that incorporates critical thinking, knowledge, skills, and values and ethics of the social work profession.

PPAD had a very solid year. Enrollment since the previous year was flat. Faculty are performing well internally and externally given the financial constraints under which the programs had to operate. Faculty continue to distinguish themselves within the discipline and in the community. However, professional collegiality among faculty is a growing challenge. All of the Department's current faculty lines are filled that should indicate stability. The support that the Department normally received from the College of Public Service and the University has not met previous levels. PPAD now faces even larger challenges as it continues to grow programs in terms of program quality, enrollment, retention and graduation.
