Fall Semester 2011(2 Credits)

The purpose of this course is to introduce the social work student to knowledge of human development as a base for social work practice. Human problems are viewed within their environmental context. Individuals, families, groups, organizations and communities are in constant transaction with each other in the physical and social environmental context. Thus, people and

environments reciprocally affect one another, and adequate assessments of human problems and plans of intervention must consider the reciprocal impact of people and a range of environmental systems.

SOWK630(MSW) Policy for Social Change

Fall Semester 2011 (3 Credits)
Explore theory and apply it to community organizing, coalition building, and advanced-policy analysis;
assess existing policies within various systems and study the impact of these policies; plan and implement a social-action project.

SOWK 462(BSW) 562(MSW) Social Work Research I & II

Fall Semester 2011 (2 Credits)

A broad range of research tools available to social workers to improve both the effectiveness and efficiency of their practice. Research methodologies, both quantitative and qualitative, are presented. Also includes a generalist overview of statistics focusing on using SPSS. Students do a research project addressing a social problem.

SOWK 410-001(BSW) Children & Families at Risk

The focus of the course is on the development of programs for the well-being of children including child-welfare programs such as juvenile courts, foster care, child-care centers, adoptions, protective services, institutional care, and special-needs services.

SOWK 475 (BSW) 675(MSW) Dealing with Difficult People

This course will focus on effective strategies to utilize in dealing with various issues which cause people to be difficult. Class presentations, readings, activities, role-plays, and discussions are forums that will be utilized to examine situations where conflicts arise. Using these essential steps to conflict resolution, students will engage in exercises to assess their own ability to collaborate and peacefully resolve conflict.

PBHL 521 Principles of Epidemiology (Online Class)

This is an introductory course in epidemiology that is designed to introduce students to the basic principles of epidemiology as they apply to public health practice. Content will include: a historical perspective on epidemiology, descriptive epidemiology, effect measures, study designs, bias, surveillance, and screening for disease.
