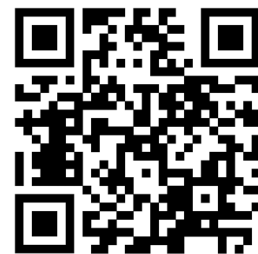
- **Who can apply:** Current or incoming COB majors with financial need.

Detailed Announcement and Application Guidelines

The Jackson State University College of Business is pleased to announce the FedEx College of Business Student Success Scholarship, made possible through the generous support of FedEx. This scholarship is designed to assist College of Business students who have financial needs that may affect their ability to continue, enroll, or remain on track toward degree completion at JSU.

Eligibility Requirements

- Be a College of Business major at Jackson State University or admitted to JSU with the intent to major in the College of Business.
- Be currently enrolled or preparing to enroll at JSU.
- Demonstrate financial need that may affect continued enrollment, registration, or degree progress.
- Complete the scholarship application by the stated deadline.
- Submit a personal statement of 250 words or less.
- Be in good academic and university standing, if currently enrolled.

Application Materials Required

- Completed scholarship application
- Unofficial copy of transcript (Freshmen can use HS transcripts)
- Personal statement of 250 words or less
- Any additional documentation requested by the College of Business or scholarship review committee

First-Time Freshmen

First-time freshmen who are selected for the scholarship will not have the award applied to their student account until they have completed registration at Jackson State University.

Personal Statement Prompt

In 250 words or less, respond to the following:

The FedEx College of Business Student Success Scholarship is designed to support students with financial need while encouraging academic progress, career readiness, and professional engagement. Please describe your financial need, your academic and career goals in business, and how receiving this scholarship would help you continue or begin your studies at Jackson State University. Also explain how you hope to benefit from opportunities supported by the FedEx partnership, such as College of Business lectures, workshops, company visits, professional development activities, or other career-readiness experiences.

Recipient Expectations

Each semester in which the scholarship is awarded, recipients must attend at least two approved College of Business activities. Examples include lecture series events, professional development workshops, employer or company visits, career readiness sessions, speaker series events, executive-in-residence programs, and other approved student success or career engagement programs. Participation may be verified through sign-in records, attendance reports, or a brief reflection.

Headshots, Recognition, and Marketing Participation

Scholarship recipients may be asked to participate in College of Business and/or JSU recognition activities related to the scholarship. These may include professional headshots, group photos, testimonials, short video interviews, social media posts, website features, printed materials, news releases, donor impact reports, or other marketing campaigns. Students may be asked to complete required university media release, photo release, or consent documentation before their image, name, likeness, statement, or testimonial is used.

Award Information: Scholarship awards are subject to the availability of FedEx funding, student eligibility, completion of all application requirements, and applicable JSU financial aid procedures. Awards may be applied to the student's university account in accordance with JSU procedures and applicable financial aid guidelines.
