PRAXIS I PPST TEST-The MDE will accept the **old passing PPST scores** <u>taken before</u> <u>9/1/2012</u> <u>until 9/1/2014</u> <u>IF</u> educator took and passed the test before 9/1/2012 and <u>applies for a license by 9/30/2014</u>. This means the educator must have completed the program and have a recommendation by the university.

The PRAXIS I PPST test is a requirement for the alternate route educators.

NEW PRAXIS TEST: Core Academic Skills for Educators (CASE)

The CASE test will begin on **9/1/2013**, BUT the PRAXIS I Pre Professional Skills Test (PPST) will be offered for test takers until 12/31/2013. After 12/31/2013, the PPST PRAXIS TEST will no longer be offered or accepted to meet certification requirements. The educator CANNOT combine parts of the PPST and parts of the CASE to meet certification requirements.

Beginning 01/01/2014, the educator must begin to take and pass the CASE in order to meet certification requirements.

The PPST test taken and passed (with increased cut scores) before 12/31/2013 will be accepted until 9/30/2015.

Praxis Core Academic Skills for Educators Tests

The *Praxis* program is pleased to announce the new *Praxis* Core Academic Skills for Educators tests in Reading, Writing and Mathematics. These new tests are aligned to the College and Career Readiness (CCR) Standards and Common Core State Standards (CCSS) and will be administered for the first time in fall 2013. These tests will replace the *Praxis* I® Pre-Professional Skills Tests (*PPST*®) in Reading, Writing and Mathematics.

These new Core Academic Skills for Educators tests are more rigorous and measure critical thinking and academic skills in reading, writing and mathematics. These new tests will provide states and agencies with a better indicator if the candidate is qualified by delivering tests that measure 21st-century skills. Key changes include:

- Praxis Core Academic Skills for Educators: Reading contains a wider
 variety of text types, with an emphasis on informational text that reflects the
 intent of the CCSS. The test will also include sets of questions that require the
 integration and analysis of multiple documents, as well as some alternate
 response types (e.g., select in passage), to enhance the authenticity of the tasks.
- Praxis Core Academic Skills for Educators: Writing reflects the importance
 of both argumentative writing and informative/explanatory writing, and will contain
 two writing tasks for each writing type. In addition, multiple-choice questions will
 be added to address the importance of research strategies and assess strategies
 for revising and improving text.
- Praxis Core Academic Skills for Educators: Mathematics new response
 formats will include numeric entry that will allow the student's means of
 responding to better match the skill that is being assessed. Test takers will have
 access to an on-screen calculator to help ensure that questions are testing
 mathematical reasoning by reducing the chance that a candidate's wrong
 response comes from a simple arithmetic error.
