

## Frequently Asked Questions for the Tiger Ready Scholarship

### Who is eligible for Tiger Ready Scholarship?

#### First Time Freshmen

- enrolled at JSU for the Fall 2022-2023 academic year
- not receiving any other institutional scholarships
- having accepted all aid offerings
- having demonstrated the need for assistance with satisfying Fall 2022 and/or Spring 2023 semester charges (completing registration)

### Are any students excluded from Tiger Ready Scholarship?

- Students who are not first time freshmen starting the Fall 2022 or Spring 2023 semester
- First time freshmen with a credit balance on the student account
- First time Freshmen who have not accepted all aid offerings.

### What do I need to do?

Complete ROAR orientation session

### When will the funds be available?

Awarding of these funds will start in July 2022

### How will my scholarship amount be determined?

The Tiger Ready scholarship amount will be determined by the remaining outstanding charges on the student's account. The Tiger Ready scholarship will cover up to \$1,000 of remaining charges for the 2022-2023 academic year.

### I did not submit a 2022-2023 FAFSA, do I qualify for the Tiger Ready scholarship?

To receive the Tiger Ready Scholarship, you are not required to be eligible to receive Federal Financial Aid.

### How do I check my financial aid status in PAWS?

1. Go to [www.jsums.edu](http://www.jsums.edu) and click on JSU P.A.W.S.
2. Login using your User ID and PIN
3. Click on Financial Aid and select the year you want to view Missing Requirements, Requirement Messages, Holds, Academic Progress, Awards and Messages from the Financial Aid Office.
4. If you have Unsatisfied Requirements, please submit them to the Financial Aid Office

**What to do if I receive another scholarship after receiving the Tiger Ready scholarship?**

Please send the scholarship information to the financial aid office at [finaid@jsums.edu](mailto:finaid@jsums.edu) so that your account can be reviewed. Any scholarship that results in a credit balance will reduce the **Tiger Ready Scholarship**.

**Am I allowed to receive a refund of the Tiger Ready Scholarship?**

Students are not allowed to receive refunds with the **Tiger Ready Scholarship**. Any credit balance will be reduced.

**What if I attended summer school or have dual enrollment credits? Am I still considered a first-time freshman?**

Yes, students who enroll in summer school right after high-school graduation are still considered first-time freshmen for the upcoming fall. Recent graduates with dual enrollment credit are also considered first-time freshmen, even if they have an AA degree upon high school graduation.

**What do you mean by "complete registration"?**

Complete registration is the term meaning that you have paid your account balance in full through financial aid, cash or credit card payment or made arrangements for a payment plan
