

INSTRUCTIONS

Your 2023-2024 Free Application for Federal Student Aid (FAFSA) was selected for review in a process called verification. Federal regulations indicate that before awarding Federal Student Aid, we must ask you to confirm the information you reported on your FAFSA. To verify that you provided correct information we will compare your FAFSA with the information on this worksheet and with any other required documents. If there are differences, your FAFSA information may need to be corrected. You and at least one parent that signed the FAFSA (or your spouse in the case of married independent students) must complete and sign this worksheet and submit the form with any other required documents to our office.

Verification of Household Size and Number in College

For Dependent Students list the people in your parent(s) household to include:

- Yourself and your parent(s) (including a stepparent) even if you don't live with your parent(s).
- Your parent(s)' other children if your parent(s) will provide more than half of their support from July 1, 2023, through June 30, 2024, or if the other children would be required to provide parental information if they were completing a FAFSA for 2023–2024. Include children who meet either of these standards, even if they do not live with your parent(s).
- Other people if they now live with your parent(s) and your parent(s) provide more than half of their support and will continue to provide more than half of their support through June 30, 2024.

For Independent Students list the people in your household to include:

- Yourself.
- · Your spouse, if you are married.
- Your children, if any, if you will provide more than half of their support from July 1, 2023, through June 30, 2024, or if the child would be required to provide your information if they were completing a FAFSA for 2023–2024. Include children who meet either of these standards, even if they do not live with you.
- Other people if they now live with you and you provide more than half of their support and will continue to provide more than half of their support through June 30, 2024.

The 2023-2024 Verification requires copies of the 2021 Federal Tax Return for each JSU student listed on this worksheet. Federal Tax Returns are required for any Parent, Step-Parent or adult aged 24 or older listed on this worksheet that did not use the IRS Data Retrieval Tool.

To Be Signed at the Institution

Students only need to complete one side of this form. If you are able to appear in person to complete the form use page 1, otherwise complete page 2 in the presence of a notary.

The student must appear in person at **Jackson State University** to verify his or her identity by presenting valid government-issued photo identification (ID), such as, but not limited to, a driver's license, other state-issued ID, or passport. The institution will maintain a copy of the student's photo ID that is annotated with the date it was received and the name of the official at the institution authorized to collect the student's ID.

Students only need to complete one side of this form. If you are able to appear in person to complete the form use page 1, otherwise complete page 2 in the presence of a notary. If submitting notarized form please submit an ORIGINAL copy, do not fax or email.

If the student is unable to appear in person at Jackson State University to verify his or her identity, the student must provide:

- (a) A copy of the valid government-issued photo identification (ID) that is acknowledged in the notary statement below, such as but not limited to a driver's license, other state-issued ID, or passport; and
- (b) The original notarized Statement of Educational Purpose provided below.
