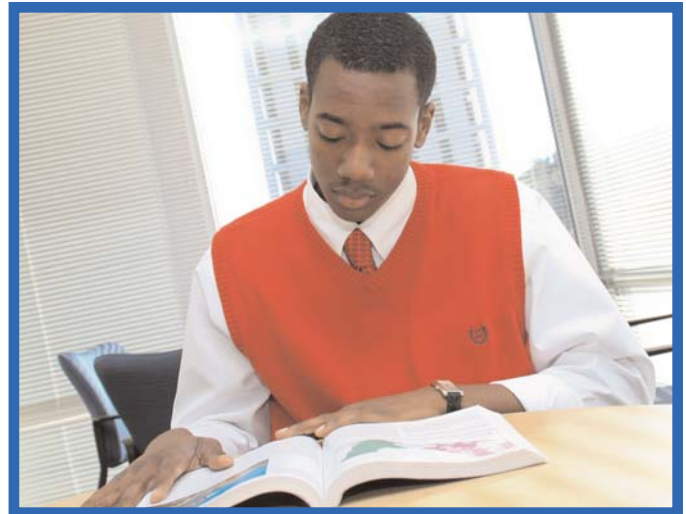

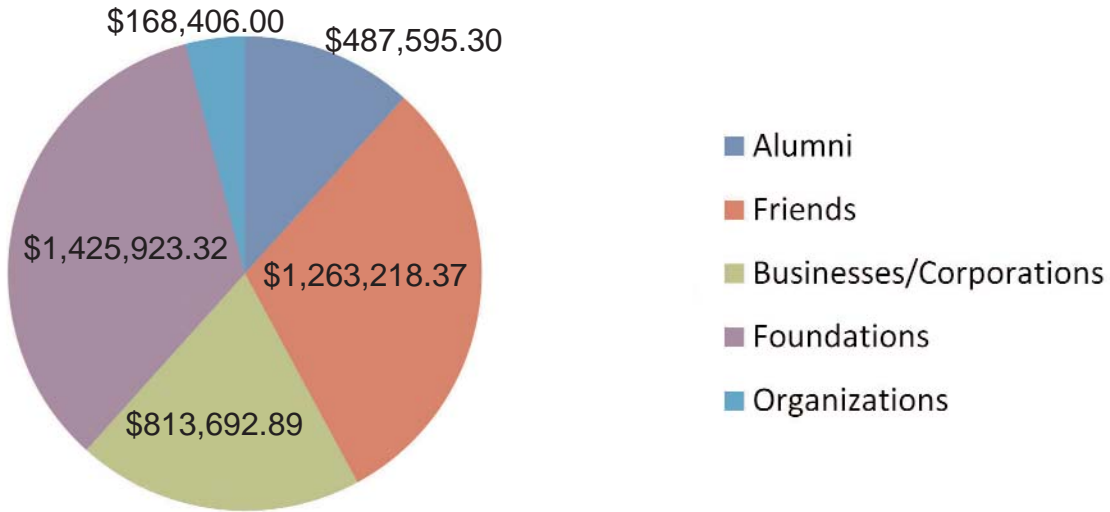

#### Gift Summary of Constituents

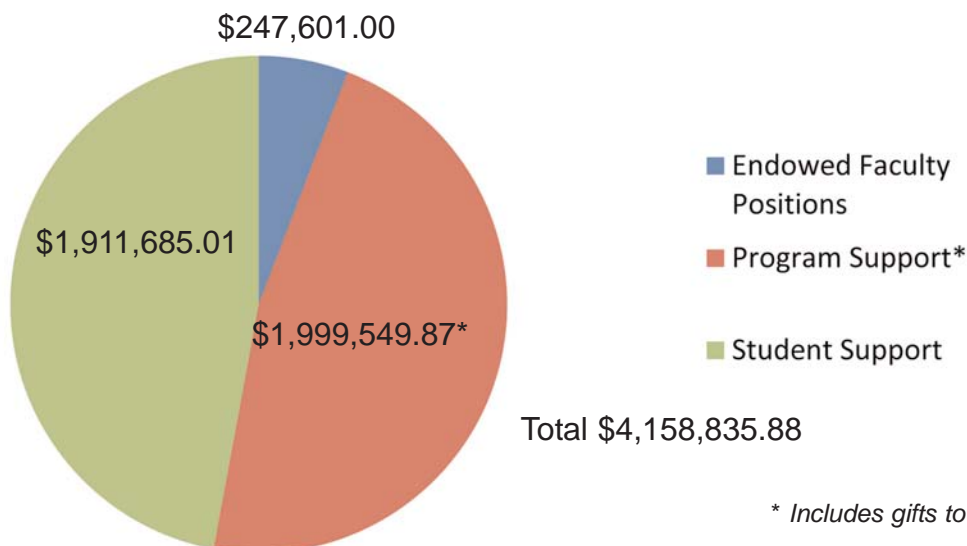
