#### **RESEARCH IN AREAS OF CANCER AND HIV**

2017-Current: Detection of Cervical Cancer in Women Infected with HIV in La Romana, Dominican Republic, Global Health Equity Program Fellow, Fogarty International Center (NIH)

- Currently conducting three linked research projects that collectively explain the influence of women's health perceptions and cultural norms to adherence and non-adherence to screening recommendations for cervical cancer among women allied to a clinical facility in a non-US setting (\$15,000).
- Study 1, retrospective study of apprx. 400 randomly selected medical records to identify socioldemographic and clinical factors associated with women who have never screened, are overdue, or up-to-date with screening recommendations.
- Study 2, cross-sectional study of up to 190 women identified in Study 1 to determine the various attitudes and perceptions toward cervical cancer screening, potential barriers to accessing care, and describe the configuration of support networks available to women served by the clinic.
- Study 3, up to 16 in-depth interviews in Spanish to identify factors that affect the completion of specialized testing among women who receive abnormal results from their cervical exam in Study 2.
- Managing all data collection activities and one staff assistant in a clinic that operates solely in Spanish.
- While waiting IRB approval, volunteered technical assistance and training to doctors who worked in a second, similar clinic on data collection. Guided their development of a survey that documented patients' health-related perceptions about anal and vaginal cancer along with screening among female and male patients. Instrument developed in Spanish and English languages.

### 2014-2016: Exploring Breast Health Perceptions, Behaviors, and Social Cohesion among Ethnically Diverse Black Women (Dissertation), William Darrow, PhD, 305.348.7789

- Conducted an eight-month, mixed-methods study to explore the influence of ethnic identity, cultural norms, and social cohesion on the decisions of ethnically diverse Black women to screen for breast cancer and describe their perceptions about breast health.
- Performed primary data collection within a community that exceeds county and State rates for Black women diagnosed late with breast cancer that included establishing a Community Advisory Board, enrolling a total of 86 African American and Caribbean women into one of 15 discussion groups, and collecting 121 self-administered surveys.
- Received funding from University of Miami, Sylvester Cancer Center to create a breast health care intervention, based upon research findings, designed for and delivered by a projected 170 community women: The BCM Model Program.

- Directed a three-month, mixed-methods study to explore barriers to HIV testing faced by Dade County residents that are African American, men who have sex with men, Haitian, and Latino to identify effective strategies to address HIV risk.

- Created the interview guide that explored barriers to testing, perceptions of HIV risk, and elicited strategies for improving participation in HIV testing.
