#### MISSISSIPPI CHILD WELFARE INSTITUTE AND CONFERENCE HISTORY

The Mississippi Child Welfare Institute was established at Jackson State University in 2003 as a part of the School of Social Work. The impetus to begin the Institute emanated from a grant awarded by the Children's Bureau, U.S. Department of Health and Human Services during the 2000 to 2004 period. The proposal was developed by Gwendolyn Spencer Prater, Ph.D., M.S.W., who was then Dean of the School of Social Work. The Institute and conference began prior to the organization of the academic colleges at Jackson State University.

The proposal submitted to the Children's Bureau resulted in a funded grant which permitted 26 committee-selected and dedicated students to participate in the education project. All of the social work students were provided tuition, stipends, and special training and educational opportunities both in-state and across the country at national conferences with the goal of preparing them for careers in child welfare. The students graduated and many attained social work positions in the field of child welfare. Mrs. Wanda Gilliam, M.S.W., Deputy Director of Programs, Mississippi Department of Human Services, was the liaison with the School of Social Work during the grant period and actively and successfully facilitated productive experiential educational opportunities for students with the Division of Family and Children's Services.

During the 2002-2003 academic year, Jackson State University's School of Social Work, in partnership with other state institutions of higher learning, and the Mississippi State Department of Human Services, under the capable leadership of Mrs. Thelma Brittain, M.S.W., initiated the Title IV-E Program in Child Welfare. The program was readily supported by the Mississippi Legislature, with strong leadership from the late Representative Charlie Capp, Chair of the House Appropriations Committee. Jackson State University's administration also provided strong support for the Institute and the conference. The School of Social Work programmatic and administrative leadership team included Drs. Prater and Ruth M. Williams as the Principal Investigator and Co-Principal Investigator, respectively, and Ms. Velma Hankins, M.S.W., as the Program Administrator.

The program continued for approximately three and one-half years, with Jackson State University serving as the lead institution for the majority of that period, with the final program year being rotated to one of the other state institutions of higher education. Numerous students at the baccalaureate and master's levels were educated and provided training for child welfare practice with vulnerable populations. In addition, during that three-year period, training was also developed and provided for foster and adoptive parents and public child welfare staff. Since that time, there has not been a consortium of state schools and programs of social work jointly engaged in Title IV-E academic programming with the Mississippi Department of Human Services.

The Mississippi Child Welfare Institute at Jackson State University, however, continues to offer its annual conference for professional development of child welfare practitioners, supervisors, administrators, faculty, and students in Mississippi, other states in the Southeastern Region, and indeed across the United States of America. The Institute partners with public and private agencies and organizations as it works to improve services to children and families including but not limited to: the Mississippi State Departments of Human Services, Health, and Mental Health, the Children's Defense Fund (Southern Regional Office), Mississippi Children's Home Services and CARES Center, Catholic Charities, and the Casey Family Programs and Marguerite Casey Foundations.

#### **PLENARY SPEAKERS**



**Fred Wulczyn, Ph.D., M.S.W.,** is a Senior Research Fellow at Chapin Hall, University of Chicago. Dr. Wulczyn is the director of the Center for Foster Care and Adoption Data, a collaboration of Chapin Hall, the American Public Human Services Association, and other research partners. An expert in the analysis of administrative data, Dr. Wulczyn's integrated longitudinal databases have assisted states in their capacity to analyze key child welfare outcomes, compare outcomes across agencies and jurisdictions, project future service patterns, test the impact of policy and service innovations, and monitor progress. In the realm of public policy, he developed the nation's first proposal to change the federal law limiting the ability of states to design innovative child welfare programs, which then led to the development of the Title IV-E waiver programs used by states to undertake system reform in child welfare programs. Dr. Wulczyn received a Ph.D. from the School of Social Service Administration at the University of Chicago. He earned an M.S.W. from Marywood University, which honored him with its distinguished Alumni Award.



**Michael A. Lindsey, Ph.D., M.S.W., M.P.H.**, is an associate professor at the Silver School of Social Work, New York University. He has published extensively on help-seeking behaviors of urban youth and taught courses on evidence-based practices and innovations in school mental health and is a standing member of the NIMH SERV study section. Dr. Lindsay earned his M.S.W. degree at Howard University and the M.P.H. and Ph.D. at the University of Pittsburgh. He was a postdoctoral fellow at John Hopkins University's Bloomberg School of Public Health.



Paolo del Vecchio, M.S.W., is the Director of the Substance Abuse and Mental Health Services Administration's (SAMHSA) Center for Mental Health Services (CMHS). SAMHSA is the lead Federal agency designed to reduce the impact of substance abuse and mental illness on America's communities. Previously, he was the CMHS Associate Director for Consumer Affairs where he managed SAMHSA's precedent-setting activities in addressing consumer participation and education, issues of discrimination and stigma, consumer rights, wellness, recovery, trauma, and others. A self-identified mental health consumer, trauma survivor, and person in recovery from addictions, Mr. Vecchio has been involved for over 40 years in behavioral health as a consumer, family member, provider, advocate, and policy maker. He graduated summa cum laude with a master's degree in social work from Temple University, has published widely and is a highly sought after national and international speaker. He has been a leader in many Federal efforts including the Mental Health Statistics Improvement Project Ad-Hoc Advisory Committee, the Federal Advisory Planning Board for the Surgeon General's Report on Mental Health, the HHS Multiple Chronic Conditions and Community Living Initiatives, and numerous others.

**Scarlett Lewis'** son, Jesse, lost his life at Sandy Hook School on December 14, 2012. Inspired by the words Jesse had written on their kitchen chalkboard: Nurturing, Healing and Love, part of a definition of compassion across almost all cultures, Scarlett, founded the Jesse Lewis Choose Love Foundation. A principle tenet of the foundation is the belief that teaching children how to effectively deal with anger is crucial to a healthy society. Ms. Lewis graduated from Boston University with a B.S. in Communications in 1990. Ms. Lewis is author of the book, *Nurturing Healing Love, A Mother's Journey of Hope & Forgiveness*.


