

## Copyright & Permissions

### Copyright

Before your article can be published in *The Researcher*, we require you to grant and assign the entire copyright in it to *The Researcher*. The copyright consists of all rights protected by the copyright laws of the United States and of all foreign countries, in all languages and forms of communication, including the right to furnish the article or the abstracts to abstracting and indexing services, and the right to republish the entire article in any format or medium.

In return, *The Researcher* grants to you the non-exclusive right of republication, subject only to your giving appropriate credit to *The Researcher* as the original journal in which your article is published. This non-exclusive right of republication includes your right to allow reproduction of parts of your article wherever you wish and permits you to post the published (PDF) version of your article on your personal web site immediately. To protect the copyright in your article, the original copyright notice as it appears in the journal should be included in the credit.

If your article is accepted for publication we require you to read, sign, and return the Copyright Agreement to us. We cannot publish your article without this approval. In the event that your article is not accepted for publication, you will be notified in writing and the copyright and all rights conferred by copyright shall revert to you.

The agreement should be signed by at least one of the authors (who agrees to inform the others, if any) or, in the case of a work made for hire, by the employer.

An author who is a U.S. Government officer or employee and who prepared the article as part of his or her official duties does not own any copyright in it. If at least one of the authors is not a U.S. Government employee, one of those non-government authors should sign the Copyright Agreement.

### Reproduction of copyrighted materials

*The Researcher* is eager for the information published in its journals to reach the widest possible audience and it encourages the reuse of figures, tables, or other materials in review articles, textbooks, and other appropriate means of scholarly communication. To ensure the long-term access of the research community to its archives, *The Researcher* holds the copyright on all copyrightable materials published in its journals but grants control of the right to reproduce the material to the original authors as long as they are alive.

Multiple copies may be made for classroom use provided 1) that no charge is made for such copies (other than a nominal charge to cover the cost of reproduction), 2) that such copies are not made or distributed for commercial advantage, and 3) that the copies bear *The Researcher* copyright notice.

Permission to use *The Researcher* material in other publications

Permission to reproduce material from articles published in *The Researcher* is managed on behalf of *The Researcher* by the general editor. In order to gain permission to reproduce material under *The Researcher* copyright, you should do the following:

- Obtain consent from one of the original authors of the paper from which you wish to extract materials. In the event that the original authors are deceased or unavailable, contact *The Researcher* general editor at [editor.researcher@jsums.edu](mailto:editor.researcher@jsums.edu) for advice.
- If your publisher needs a formal indication of this permission, send a request to [editor.researcher@jsums.edu](mailto:editor.researcher@jsums.edu). If special forms are required by your publisher, be sure to include copies of the forms. Requests for formal permission will normally be satisfied within a week of the request.
- All reproduced material must be properly identified by the citation of the original publication and include the phrase "reproduced by permission of *The Researcher*."
