Differentiating

Student Conduct / Judicial



Examples:

- A student in an office says "This is bullsh**!"
- A student in the classroom continuously interrupts the professor.

Crisis Alert Team

Examples:

- Physical assault on campus with no suspect identified
- Multiple reports of cars being disabled

A **Crisis Alert Team** meets as soon as possible to determine notification(s) and institutional response. Key word is **ALERT**.

Behavioral Assessment Team members are on the Crisis Alert Team.

Behavioral Assessment Team

Examples:

- A student talks about emulating Cho of Virginia Tech.
- A student draws a picture of himself holding a gun in a classroom.

Logistics of a Team

Think of 4-6 people who should serve on a (core) Behavioral Assessment Team on your campus.

- Who handles safety?
- Who handles student conduct?
- Do you Mental Health counseling? Or a Student Health Center?
- How about a faculty member or liaison?
- If you have a Crisis Alert / Management Team, that's a good place to start in selecting the Team.

Member Characteristics

Characteristics are equally important:

- Problem solving skills
- Calm in a crisis
- Communicator
- Student-centered, conscious of safety
- Can roll with things! Adaptable, Flexible
- Able to prioritize
- Trust
- Respect

Common Team Names

- ❖ Behavioral Assessment Team (BAT)
- ❖ Behavioral Intervention Team (BIT)
- ❖ Threat Assessment Team
- ❖ Threat Management Team
- ❖ Behavioral Assessment and Recommendation Team
- ❖ CARE Team

Information, *not* Diagnosis

Questions = information

Information gathering =
assessment

CASE STUDY #2

Student expresses interest in purchasing a weapon because of a grade.

CASE STUDY #3

Writing assignment that includes an analogy about weapons.

CASE STUDY #4

A student, a trenchcoat, and a trash can.

CASE STUDY #5

Evening class and a disgruntled student who mentions wanting to harm the faculty.

CASE STUDY #6

Student angry about their financial aid.
Makes an explicit threat.

CASE STUDY #7

Notification about a student who is transferring to your college, who has a history of threatening behavior.
